With regard to the Scheme for internship/e-internship of Law students with the High Court of Jammu and Kashmir, a large number of applications have been received from Law students across India from highly acclaimed Law Institutes. The applicants have been deputed to intern with judges of the High Court.

In the interaction organized on 16<sup>th</sup> September 2020 about 150 applicants participated. The interaction highlighted the difficulties being faced by students as at present. The interns made useful comments and posed pertinent questions, seeking insight into law and related issues.

Anxiety about the impact of the COVID-19 pandemic on the legal profession has been expressed by the law students at all levels. On account of the current restrictions, law students stand deprived of the benefits of clinical workshops, interactions with and lectures by experts which were available prior to the social distancing restrictions. These programmes went a long way in enabling students to make critical career choices. In order to provide an exposure to our interns and with the further objective of providing knowledge, information and opportunity to them, a series of lectures and interactions as below have been organized.
