- vii. That the man power including the catering staff and waiters shall be in proper uniform and shall maintain discipline.
- viii. That the rates as well as the quantity shall be mentioned on the menu for information of consumers/customers strictly as per the approved rate list.
- ix. That the rates quoted shall be inclusive of GST.
- x. That the net weight should be exclusive of weight of wrapper, box and carry bag under all circumstances.
- xi. That the approved rate list shall be displayed at the conspious places in the canteen premises.
- xii. That the quantity of standard of preparation shall be as per the fssai Act 2006.
- xiii. That the food items shall be as per the quality standards laid down under fssai Act 2006.
- xiv. That the service provider shall issue proper bills to the customers.
