Subject: Information regarding allottees of chambers who have not deposited any fee/rent or partial fee/rent of the chambers.

Sir,

This is to bring to your kind notice that 213 Lawyers' Chambers, situated near the District Court Complex, were allotted to the Advocates in two phases vide High Court order no.949 and 953 dated 02.01.2016 on monthly fee/rent of Rs.400/- to be deposited with Registrar Judicial, High Court Wing Jammu by the main allottee.

It has been reported by the Officer Incharge of Lawyers' Chambers that no fee/rent has been deposited by the allottee Advocates in respect of 10 chambers and 53 allottees have deposited less than 50% of the fee/rent due.

The said matter was put forth before the Hon'ble Committee for allotment of Chambers in the meeting held on 21.08.2024 and the Hon'ble Committee has been pleased to direct the undersigned to furnish a list of allottees of chambers who have not deposited any fee/rent of the chambers till date and who have deposited partial fee/rent (less than 50%) till date to your goodself. The Hon'ble Committee has also directed the undersigned to convey that in case the allottees, who have not deposited any fee/rent till date, fail to clear their dues within 15 days, their allotment would be cancelled and allottees who have deposited only partial fee/rent till date, fail to clear their dues within 15 days, process for cancellation of their allotment would be initiated. A list of ten (10) allottee Advocates who have not cleared their dues is enclosed herewith as "Annexure-A" and a list of fifty-two (52) allottees who have only deposited partial fee/rent is enclosed as "Annexure-B".

You, are therefore, requested to taking due steps in the matter from your office and also affix the instant communication at such place where it can come to the notice of members of the Bar Association.
