Method of Recruitment/Eligibility:

- (i) The limited competitive test shall consist of two written papers. The first paper regarding questions relating to Laws and Procedures carrying 100 marks will have duration of three hours. The second paper carrying 80 marks, will require the candidate to frame and write in a duration of 90 minutes, two judgments (each carrying 40 marks) one in Civil matter and the other in Criminal one.
- (ii) Viva voce test shall carry 20 marks.
- (iii) The selection of the candidate shall be made on the basis of cumulative grade value obtained in the written examination and viva voce test.
- (iv) Only those candidates who secure 70% or more marks shall be declared successful. The appointments to the post shall be made on vacancies available for the category (b) of Rule 5 on the basis of inter-se merit of successful candidates.

The applications should reach this Registry on or before 11th August, 2024.
