Subject:- Judgment dated 10.04.2023 passed by Hon'ble Supreme Court in Writ Petition (Civil) No.82/2023 titled Ajay Shankar Srivastava Vs. Bar Council of India & Anr for implementation of Certificate and Place of Practice(Verification) Rules-2015. c/w Transferred Case (Civil) No 126 of 2015 Titled Ajayinder Sangwan Vs. Bar Council of India & Ors.

Whereas, the Bar Council of India, vide communication No.BCI:D:1726/2024 dated 10.04.2024, has informed that the Hon'ble High Powered Committee constituted by the Hon'ble Supreme Court vide Judgment dated 10.04.2023 passed in Writ Petition (Civil) No.82/2023 titled Ajay Shankar Srivastava Vs. Bar Council of India & Anr to monitor the process of verification of genuineness and validity of degrees/certificate of advocates enrolled with the State Bar Councils. The relevant portion of Judgment of the Hon'ble Supreme Court reads as under:-

- "
3. *In 2015, the Bar Council of India notified the Bar Council of India Certificate and Place of Practice (Verification) Rules 2015. The process of verification of certificates and place of practice commenced with efforts by the State Bar Councils and the Bar Council of India.*
 9. *The above table indicates that a majority of advocates enrolled with the State Bar Councils have not submitted their verification forms. The Bar Council of India apprehends that many advocates who have not submitted their forms for verification are persons who are not qualified or are "in possession of fake degrees". The Bar Council of India has submitted and, with justification, that this class of persons, without the possession of qualifications required for law practice, is known to enter upon the arena of courts for extraneous purposes, including the disruption of work. The Bar Council of India is justified in asserting that such persons have to be identified and weeded out from the list of advocates enrolled with the Bar Councils.*
 10. *The due verification of advocates who are enrolled with the State Bar Councils, is of utmost importance to preserve the integrity of the administration of justice. Persons who profess to be lawyers, but do not either have the educational qualifications or degree certificates on the basis of which they could have lawfully granted entry to the Bar, pose a grave danger to the administration of justice to citizens. Hence, it is the duty of every genuine advocate of the country to ensure that they cooperate with the Bar Council of India which is seeking to ensure that the certificates of*

practice are duly verified, together with the underlying educational degree certificates. Unless this exercise is carried out periodically, there is a danger that the administration of Justice would be under a serious cloud. The written submission which has been placed on the record by the Bar Council of India indicates that several such persons have been elected to State Bar Councils and some persons have thereafter occupied judicial office in the district judiciary as well".

- i) Therefore, all those of advocates enrolled on J&K Bar Council, who have not submitted their verification forms in terms of Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015, are hereby directed to submit the same before Principal District and Sessions Judge concerned and Registrar Judicial High Court Wing Jammu/Srinagar respectively along with requisite documents viz; two passport size photographs, self attested copies of Enrolment Certificates, Matriculation/LL.B Degrees alongwith fee by way of valid Demand Draft of Rs.200(100+100 late fee) each in the name of Secretary, J&K Bar Council within 15 days from the date of issue of notice in the daily newspaper.
- ii) All the concerned Advocates enrolled on the roll of J&K Bar Council, who have submitted their Verification Forms in terms of Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015 and pursuant to the Notification No(s) 512 dated 21.07.2016, 571 dated 04.08.2016, 580 dated 07.09.2016, 1990 dated 31.03.2018 and 1273 of 2023 dated 12.07.2023 of the Hon'ble High Court of Jammu & Kashmir and Ladakh are hereby directed to make up the deficiencies as per the **Annexure "A"** and submit the two photographs, the self attested copies of enrolment certificates, Matriculation-(DOB) and LL.B Degree, if they have not submitted the same, along with their verification Forms, before the concerned Principal District and Sessions Judge and Registrar Judicial High Court Wing Jammu/Srinagar respectively within a period of 15 days from the date of publication of this Notice in the News paper.
- iii) The concerned Registrar Judicial's, High Court Wing, Jammu/Srinagar and Principal District & Session Judges shall receive only those verification forms that are complete in all respects under Certificate and Place of Practice(Verification) Rules, 2015 and forward the consolidated data as per Format in Excel Format on email address **lpsection31@gmail.com**.
- iv) The Registrar Judicials', High Court Wing Jammu/Srinagar and all Principal District & Session Judges and the courts under their jurisdiction and the Presiding Officers of the Tribunals shall ensure that only those of the advocates who possess the valid advocate license/Certificate of enrolment shall be allowed to practice in the concerned courts.

- i) Applications complete in all respects aforementioned shall only be entertained.
- ii) Concerned Registrar Judicials' and Principal District & Sessions Judge's shall forward the consolidated data as per prescribed Format in Excel Format on e-mail address: lpsection31@gmail.com.
